BEFORE ME, the undersigned Judge of MAGISTRATE Court, Parish of Orleans, State of Louisiana, personally came and appeared: Officer Gary J.Calico, Badge 1205, employed by the New Orleans Police Department, 715 South Broad Street, New Orleans, Louisiana,

WHO, after first being duly sworn by me, deposed and stated that a warrant of arrest should issue ordering the arrest of James Radcliff w/m 12-16-1958 who on the 18th day of December 2004, in the Parish

of Orleans, State of Louisiana, did commit the crime of Assault by Drive by Shooting defined in the Louisiana Revised Statute R.S. 14:37.1 The

facts and circumstances given to support the issuance of this warrant are:

On Saturday, December 18, 2004 there was a drive by shooting in which the suspect fired two gunshots at the victims on the Interstate while the suspect was in his vehicle and the victims traveled in their vehicle. The victims were able to copy the Louisiana license plate number *PADRES*, from the suspect vehicle and observed him to be a white male in his 40's. The victims did not sustain any injuries or any property damage as a result of the incident. The victims believed this to be an apparent case of road rage, which started in Jefferson Parish in a motor vehicle accident where the suspect rammed the victims vehicle.

After conducting a Mobile Data Terminal check via Motions, the aforementioned plate was registered to James Radcliff at 444 Helio's Ave in Metairie, La. Armed with this information, Officer Calico compiled a photographic lineup of the suspect.

Officer Calico relocated to 7434 Benson St. to allow the victims to view the photographic lineup.

The victims separately identified the suspect James Radcliff positioned in the number 2 position as the person who fired a handgun at them.

Officer Calico preys a Warrant of Arrest be issued for the above named Suspect.
